General Rules

Thursday, August 13, 2026 – 5:30 p.m.

The following General Rules apply to all entries in the Illinois State Fair Twilight Parade. The rules have been created in the interest of safety of parade participants and spectators, to ensure a quality parade, and minimize the length and duration of the overall event.

The 2026 Illinois State Fair Twilight Parade theme is *Miles of Smiles*.

1. All parade entries must conform to the parade theme.
2. A committee will screen all entries for entertainment value, and approximately 60 entries will be selected for participation in the parade. Conformance to the theme or “atmosphere” of the Fair will be a major component of the selection of entries.
3. The parade committee will evaluate and select entries based upon information provided in the parade applications. Failure to provide complete information or to comply with the rules may result in an entry being disqualified. The parade committee reserves the right to limit, or recategorize entries based upon their discretion. All decisions of the committee are final.
4. A \$25.00 entry fee is required for each selected entry plus additional fees dependent upon number of participants or category entered. This fee shall be submitted after notification of acceptance by the committee to the Special Events Office of the Illinois State Fair.
5. All applicants will provide detailed drawings or descriptions of entries. Any major changes to the original entry must be approved by the committee or the entry will be disqualified.
6. All entries must be postmarked, or hand delivered to the Illinois State Fair Special Events Office by close of business on **Monday, July 6, 2026**.
7. No entry will be accepted unless the application has been completed in full.
8. Candy, samples, or other materials of any type may **not** be thrown from, or distributed from, floats or vehicles. Parade walkers may distribute materials to parade spectators by walking to the curb and handing material out. Law enforcement, Parade Marshals, and Parade Officials may, without warning, remove entries from the parade if this rule is violated.
9. It is the policy of the Illinois State Fair Twilight Parade to showcase the Miss Illinois County Fair Queen. No other queens or royalty will be allowed to ride in a vehicle as a single entry. Other queens or royalty may participate but must appear in conjunction with an accepted parade entry.
10. All entries must display their assigned parade entry number on the front of the unit. This number will be provided to entries in the staging area.
11. Formal instructions for staging of entries will be provided to those entries selected to participate in the parade.
12. The parade has contests for Marching Bands, Floats, and Specialty Units. Please see specific rules on the following pages for each of these contests.

3. **Competition Area:** The competition area is in front of the Reviewing Stand inside the Main Gate of the Fairgrounds. It is indicated by two taped lines; one indicating the beginning and the other indicating the end. The total competition area is approximately 100 yards long. Each marching band will mark time until the entire competition area is clear of other entries and then given the instructions to proceed.
4. **Musical Requirement:** All marching bands are required to play a selection of their choice while marching through the competition area. Marching bands cannot stop while marching through the competition area to perform routines and will have points deducted from the overall score. Marching routines are allowed if forward movement is maintained.
5. **Announcement of Awards:** Awards will be announced at the conclusion of judging process. Band directors will be mailed the judging sheets. The 2026 First Place winner will be invited to participate as the 2027 Twilight Parade Honor Band.

The following rules apply to entries of floats in the Illinois State Fair Twilight Parade:

1. Float entry applications **must** include a drawing or photograph of the proposed entry.
2. Each entry should incorporate the parade theme or an "atmosphere" of the Fair in the design of the float.
3. The committee encourages all floats to be covered with sturdy materials such as vinyl sheeting, enamel paint, or other materials which will hold up under adverse weather conditions. Floats covered with paper napkins or other materials may be destroyed in adverse weather conditions or strong winds. All parts of the float, including wheels, must be completely covered by materials.
4. Floats must bear the name of the participant or organization and the title of the theme that the float depicts. This can be on the float proper or printed on a banner that would be carried in front of the float. All signage must be high quality and easily legible.
5. For the safety of parade participants and parade spectators, each float may be accompanied by up to eight (8) escort personnel. Two banner/sign carriers will be allowed per entry. The banner/sign carriers are not included in the escort personnel count.
6. **Floats shall be no more than 36-feet long, 10-feet wide, and 13-feet high.** These dimensions are exclusive of the tow vehicle (if applicable).
7. Decorated cars, trucks, or vans are not considered floats and will not be accepted in either of the float categories.
8. For purposes of judging, Commercial Floats are those which have been designed and built for a business or organization that sells goods or services for profit, and Non-Commercial Floats are those which have been designed and built for groups or organizations that are not-for-profit, i.e., charities, volunteer groups, etc.

3. Contestants may only enter one class. All First-Place winners from the 2025 Illinois State Fair are not eligible to compete in the same class in the 2026 Illinois State Fair.
4. Baton twirling, use of machetes, knives, objects that resemble firearms, or other props is not allowed.
5. A contestant considered to be a professional is not eligible for this contest. For purposes of this contest a professional is defined as anyone who is a union member, music teachers, band leaders, anyone who has a professional manager, or whose principal and/or supporting income is derived from performing.
6. Performances are limited to no more than four (4) minutes. Performances that run over the four (4) minute requirement are disqualified.
7. Each contestant is required to submit a list of selections and the means of accompaniment (tape, piano, amp, musical instrument).
8. In vocal classes, instrumental accompaniment by the contestant, or others, is allowed, however the contestant will be judged on whether the vocal performance would stand alone if no accompaniment were provided. No voices or vocal utterances may be used on recorded accompaniment for vocal classes.
9. In instrumental solo classes, accompaniment is allowed, however the contestant will be judged on whether the performance would stand alone if no accompaniment were provided. No instrument of the same nature as the solo instrument may be used as accompaniment.
10. In dance classes, accompanists are permitted on stage but may not assume visual importance in the performance. Acrobatic or gymnastic movements will be allowed in dance classes but cannot consist or more than 20% of the overall routine.

2. Pre-registration for this event is highly encouraged as number of contestants is limited. To Pre-register contact Illinois State Fair, Office of Special Events at (217) 782-0777 or (217) 782-6661.
3. Registration day of contest will be accepted, if there are still spots available, and will be done at the Lincoln Stage on the Fairgrounds from 3:30 PM to 4:00 PM.
4. All children must compete in diaper attire. This may consist of a cloth or disposable diaper.
5. Heats of no more than four (4) children at a time will be held. Heat winners will compete for the overall prize.

The following rules apply to entries in the Illinois State Fair Auctioneers Bid Calling Contest:

1. The contest shall be limited to the first 20 entries received. If the limit is not reached, additional contestants may be at the call of the committee. Each contestant should dress appropriately for a professional presentation. Past ISAA Champions are not eligible to compete in future Illinois State Auctioneer Championships.
2. Contestants shall be 18 years of age or older, current, paid members of the Illinois State Auctioneers Association Inc. and hold a current auctioneer license in the State of Illinois. There shall be one division combined for men and women.
3. Contestants must pay the \$100 non-refundable entry fee, by 9:00 PM on Tuesday, August 18, 2026. All entries will be date “stamped” when received. In case of cancellations, substitutions will be at the call of the committee. An auction market, auction company, private company or businessperson, association, newspaper, etc. may sponsor a contestant.
4. Contestants must provide (3) items that should sell for \$50 or more each that he/she shall sell consecutively in the Preliminaries Round. Each item must have the contestant’s business card or name firmly attached to the item, and if he / she wishes to specify the order of selling those items, each should be clearly indicated as #1, #2 or #3.
5. The sound system shall be preset. Contestants will be allowed to test it in advance but cannot adjust it during the contest.
6. In the Finals each contestant will sell items provided by ISAA with a value equal to other contestants’ items. All proceeds from the sale of items will be used at the discretion of the ISAA.
7. Competing order will be determined prior to the event by a draw, conducted by the Championship Committee Chairman during the Mandatory Roll Call and Orientation Meeting.
8. ALL Contestants MUST attend the Contestant Roll Call and Orientation Meeting at 9:05 AM, on Wednesday. Roll Call will be taken at the start of the meeting promptly at 9:05 AM. In the event a contestant is not present during the initial roll call, his/her name will be called 2 additional times at 5-minute intervals. In the event a contestant is not present when his / her name is called the third and final time, he / she will be disqualified from the contest, without return of entry fee.
9. Contestants may request a copy of these rules and sample score sheets.
10. The score system used for the International Auctioneer Championship Contest will be used.
11. A panel of at least three judges will be selected by the committee. The judges may be either auctioneers or members of the community.
12. Scores from the Preliminaries will determine who advances to the Finals round. The number of finalists shall be based on the following sliding scale: 10 or fewer contestants – Five Finalists; 11 to 20 contestants – Six Finalists.
13. If a tie score occurs in the Preliminaries, scores will be recalculated and the lowest score for each contestant shall be eliminated. In the event there is still a tie, the highest score in the Chant / Voice category will be used as the tiebreaker.

14. Finalists will be announced after the conclusion and the scoring of the Preliminary Competition. Each Finalist will be asked to report to an isolated room for instruction on the interview portion of the competition. A separate drawing will determine the order in which the Finalists participate. Finalists will sell items provided by ISAA.
15. During the Interview Portion of the contest, Finalists shall be isolated in a room until it is his / her turn to be interviewed. Cell phones / cell phone usage is NOT allowed by Finalist while in isolation. The Interview Portion is the only part of the contest with isolation restrictions.
16. Finalists will be asked two questions by the emcee developed by the contest committee. A time limit of two minutes per question will apply after the question has been read. The contestant may ask to have the question repeated only once.
17. Final scores are determined by combining the interview score with the bid-calling finals score. If a tie occurs, scores from the Preliminaries will be used as the tiebreaker in the Finals.
18. The following prizes will be awarded: CHAMPION - \$1,000 Check, Championship Buckle & Plaque. 2027 ISAA Membership Dues & ISAA Conference Registration, Reimbursed Entry Fee for the 2027 International Auctioneer Championship Contest, if he/she represents Illinois. FIRST RUNNER-UP – \$250 Check & Plaque. 2027 ISAA Membership Dues & ISAA Conference Registration. SECOND RUNNER-UP – \$150 Check, Plaque and 2027 ISAA Membership Dues.
19. Contestants shall not be given the exact order of finish. Score sheets will be provided after the contest.
20. The winner shall be referred to as “2026 Illinois State Champion Auctioneer.”
21. The champion shall make promotional appearances on behalf of Illinois State Auctioneers Association, including but not limited to, the Governor’s Sale of Champions auction at the Illinois State Fair upon championship year, the International Auctioneer Championship Contest and will be the Emcee for the following year championship contest. The Illinois State Champion Auctioneer shall wear a shirt with the ISAA logo when representing ISAA.
22. The Committee Chairmen or his / her designee(s) shall address, as needed, any additions, errors or omissions regarding rules and regulations of the contest. The decision of the committee shall be final and binding at the time a decision is made and shall apply to all contestants. Ringmen will be selected by the Committee Chairmen.

 - b. Entry Limits:
 - i. The maximum number of registered teams per division is 25.
 1. Registrations will be accepted on a first-come basis.
 - c. Number of participants must be provided to secure admission passes for the event.
2. Divisions:
 - a. Game Day Cheer
 - b. Dance Team Halftime
 - c. Time Limits:
 - i. Game Day: 2:30 minutes

If participation numbers do not meet the ICS competition requirements, the event may not be recognized by the ICS and winners may not advance.
2. Entry fees are \$35.00 for Red Chili and \$25.00 for Chili Verde and Homestyle Chili. Applications are made through the ICS website. Fees will be paid day of event. Entry into any two of the three categories will allow the entrant to enter the third category without fee.
3. Contestants entering as an ICS competitor must be a member of the International Chili Society prior to competing, however, membership can be processed at the time of competition. ICS membership fees are \$10 for a one event cookoff. Cookoff fees are waived for first time cooks. ICS rules will be used.
4. Contestants shall supply all cooking ingredients, cooking devices, utensils, etc. ICS competitors must prepare their chili onsite, from scratch. Public Health Department rules require contestants to have a receipt for all food items, and contestants must wear hats or hairnets during the competition. Tavern/Restaurant competitors with valid food handlers' licenses issued by the Illinois Department of Public Health can prepare their entry(s) in their place of business and do not need receipts. All entries prepared in this manner will be inspected and checked for temperature when they are assigned a table on the day of competition.
5. Tables will be provided, and assistance with transporting supplies is available.
6. Parking is available at a lot adjacent to The Shed.
7. Contestants may enter in all classes.
8. The ICS suggests cooks provide 2-gallons of "People's Choice" Chili for sampling by the public.
