Entries

Required fees include \$25.00/head (entry fee) and \$10.00/head (manure). Entries in all classes shall be made through the online fair entry system at the Illinois State Fair website. Entries in all classes shall be made through the online fair entry system at the Illinois State Fair website. Payment must be made via credit card at the time of entry. No other type of entry will be accepted. Assistance with entries is available at the Competitive Events Office, Monday-Friday 8 a.m. to 4 p.m. All entries must be submitted online by 12 noon on July 15, 2024. Fees will not be refunded. Late entries will be accepted through July 31, 2024, with an additional \$50.00/exhibitor charge assessed.

Department Rules

1. Each exhibitor must comply with the Illinois Exhibition Health Requirements; Animal Care, Drug, Testing and Welfare Policies; and General Rules of the Open Livestock Division.
2. Open Show exhibitors not entered in the Junior Show are reminded they must adhere to the Open Show Check-in and processing requirements in order to exhibit in the Open Show. Exhibitors showing in both Junior and Open Shows and checked-in through Junior Show processing do not have to check-in separately for the Open Show as Junior Show check-in will fulfill Open Show requirements.
3. Purebred animals must be recorded in their respective National Breed Book as evidenced by official registration. Original registration papers only must be available to the Superintendent at the time of check-in. In extreme emergencies, a faxed copy of the registration paper from the National Association, accompanied by a cover letter, may, at the sole discretion of the Superintendent, be accepted. Absolutely no copies of registration, stamped duplicate of official registration, pending registrations, or applied for documentation will be accepted.

4. Exhibitors are responsible for having his/her animal's ears clean, knowing where the tattoo is and knowing it can be read by officials at time of entry processing. All ear tags, except for button EID tags and calfhood vaccination tags, will be removed from heifers and steers at check-in.
5. Exhibitors should check with the Superintendent in the Open Beef Cattle Office before making stalls and must use stalls assigned by the Superintendent. No stalls may be bedded, and no tack will be allowed on the fairgrounds prior to the identified date stalls are available.
6. Tie-out space will be assigned by the Superintendent beginning Monday morning. If bedding is placed in the tie-out area prior to the Fair, the exhibitor will be required to remove it and place it in the assigned tie-out space.
7. Due to the amount of stalling space available, no nurse cows are allowed.
8. Only one (1) hanging fan per animal will be permitted in the Open Livestock Barns. No misters, swamp blasters, air conditioning units, freezers or similar appliances or cooling systems of any kind will be allowed. Generators and electrical fans, or equipment of any kind, are not allowed in the tie-outs. Any exhibitor's stalls or tie-outs found with any of the above will be immediately disqualified from exhibiting.
9. The Beef Department Open Show will be governed by rules and specifications set forth by the National Breed Associations, unless otherwise specified. The Superintendent will make decisions concerning interpretation of such rules and regulations and, along with the General Livestock Superintendent, shall have full authority regarding show eligibility.
10. In individual classes, the exhibitor is defined as the person whose name appears on the registration paper as the owner. In group classes where the herd is one (1) unit with animals registered in the names of different members of one (1) family residing on one (1) farm, entries may be made under the name of a single exhibitor.
11. Breeding Animal classes will be determined at the end of check-in utilizing the futurity system of entry and class division.
 - a. Age requirements for the heifer classes extend from September 1, 2022, to March 31, 2024.
 - b. All Senior Females must be confirmed safe in-calf with documentation from a veterinarian.
12. Any class of breeding animals with twenty-six (26) or more head will be divided by birthdates into two (2) distinct premium eligible classes.
13. Substitute animals will be accepted for breeding animals up to the entry processing and check-in deadlines.
14. Each exhibitor may make only one (1) entry in group classes. No group entries will be added/allowed after an exhibitor's animals have been checked in.
15. The following grooming rules will be strictly enforced, and exhibitors found in violation of these rules, either prior to entering the ring or while in the ring, will be immediately removed from the show.
 - a. Dying or artificially changing the color of an animal is prohibited. Coloring agents may only be used up to the hock (knee). Powders are not allowed on any part of the animal. Animals will be given a white towel test as they enter the showing.
 - b. Cattle are to be shown in their natural conformation. The use of false tail heads is prohibited, as is the addition of hair, hemp, or any similar substance to any part of an animal.
 - c. Tail ties are prohibited, as are spiked show halter leads and nose rings for breeding stock or steers.
 - d. Excess adhesive on the legs beyond what is needed to groom the animal's hair is prohibited.
 - e. No aerosols will be permitted in the make-up area. Any aerosol cans in the make-up area will be confiscated by Department Staff.
16. When on exhibition in the Livestock Center, each animal must be under halter and properly controlled by the exhibitor. Additionally, exhibitors must wear an arm card corresponding with the number in the official program. If the arm card is not visible, the exhibitor may not exhibit his/her animal.

17. Any animal displaying repeated unruly behavior will be dismissed from the class at the discretion of the Superintendent.
18. Family bred and raised animals entered by Junior Exhibitors in the Junior Show and subsequently entered in the Open Show may be treated as family entries in group classes.
19. Exhibitors must wait until 7:00 p.m. to move animals into tie-outs.
20. Animals must be washed in wash racks. No washing of animals in any barn.

Specific Rules for Steers

21. Steers may be purebred or crossbred. However, all steers properly registered with a breed association will be eligible for Land of Lincoln awards provided the animal meets all Land of Lincoln eligibility requirements.
22. Steers must weigh 900 pounds or more to be eligible to show.
23. Steers will be shown by weight classes within each breed. Animals will be placed into weight divisions and classes of generally equal numbers of animals based upon declared weights made at check-in and in so far as possible all class breaks will be at the discretion of the Superintendent.
24. Breeds will be shown in the order posted by the Superintendent. Watch and listen for announcements. Exhibitors must check posted class assignments and be at the showring with his/her animal when the assigned class is called.
25. Practice scales will be available in the barns for use by exhibitors.
26. Steers will have tattoos checked during processing. Exhibitors should bring a fully completed and legibly written entry/check-in card, and, if applicable, Land of Lincoln certificate or registration certificate with them at the time of processing. An exhibitor who fails to bring his/her steer to check-in and processing will be disqualified from showing.
27. Each steer will be identified, and ear tagged during entry processing. The ear tag is the official exhibitor number. Land of Lincoln eligible steers will be tagged in the right ear. Non-Land of Lincoln Junior Show entries will be tagged in the left ear.
28. Any steer properly nominated on the Premiere Nomination Form is eligible for the Premiere Class.
29. Additional eligibility requirements to show in the various breed steer shows are listed under specific breed rules.
30. Fair management reserves the right to disqualify any steer for being over age and to move or properly enter any steer not exhibiting specific breed characteristics for the breed classification entered. These requirements will be closely examined by the Superintendent and his/her assistants who, along with the General Livestock Superintendent, shall have full authority regarding show eligibility.
31. In the Land of Lincoln Open Beef Show, the Champions and Reserve Champions of Angus, Hereford, Polled Hereford and Shorthorn may have DNA collected to verify breed characteristics should the Land of Lincoln Purebred Breeders Association Board of Directors so desire. Any breeder and/or exhibitor found to be in violation will not be awarded premiums and/or awards.

Specific Breed Rules

Angus

32. Eligibility requirement to show is Purebred with an American Angus Association registration certificate. Angus registration paper will indicate effective date of ownership. Land of Lincoln certificates are not needed and will not qualify a steer to show with the Angus.
33. Steers must be free of horns or scurs. Scurs are defined as any portion of horny tissue attached to the skin of hornset of a polled animal.
34. Steers with white skin above the underline or on leg, foot or tail shall not be eligible for registration and will be barred from competition.

35. All entries are subject to DNA marker or blood typing for parentage verification at the discretion of American Angus Association.
36. Individual classes of both sexes will be divided by an appointed committee as nearly equal as possible with no more than thirty (30) classes. Variation of division of numbers per class will be dependent upon age differential. The appointed committee will make official division of classes no later than twenty-four (24) hours after the official stalling deadline and not before twelve (12) hours after stalling deadline.
37. For an exhibitor to be eligible for premium monies contributed by the American Angus Association, exhibitors are subject to the Association Rules as found in the breeder Reference Guide of the Association. These rules are found in Part 2: Association Rules. The rules relating directly to the exhibition of Angus Cattle are Part 2: Association Rules; Rule 800 Series; including Rule 800-810. The rules can be found at www.angus.org.
38. Authorized representatives of the American Angus Association have the authority to enforce the rules set forth herein, as well as the Association Rules, including the barring of registered animals from a livestock show at which it is to be shown if there are reasonable grounds to believe a violation has occurred.

Hereford and Polled Hereford

39. All steers showing at the Illinois State Fair must be registered by the American Hereford Association (AHA) and out of a registered sire and dam. No steer certificates will be accepted, only registration papers. Hereford registration papers will indicate effective date of ownership.
40. Exhibitors in Hereford classes are subject to the Association's special rule on class qualification, and any animal without a legible tattoo will not be eligible for show.
41. There are separate shows for horned and polled Herefords; therefore, horned or dehorned cattle must show in the horned show while polled and scurred cattle must show in the polled show. Any tampering with scurs will disqualify the animal from competition.
42. Individual classes of both sexes will be divided by an appointed committee as nearly equal as possible with no more than thirty (30) classes. Variation of division of numbers per class will be dependent upon age differential. The appointed committee will make official division of classes no later than twenty-four (24) hours after the official stalling deadline and not before twelve (12) hours after stalling deadline.
43. All steers must have a basic DNA test on file at the AHA. Exhibitors should contact the AHA customer service department by calling 816-842-3757 or by email at records@hereford.org to request a DNA kit for their steer. The exhibitor must be a member of the AHA or NJHA to request a basic DNA test which includes genetic profile, genetic abnormalities, and parent verification, if parent DNA is on file. At the time of check-in, exhibitors will be required to present a registration paper and letter from the AHA stating their steer's basic test DNA profile is on file. Further, all Hereford steers entered for exhibition are subject to additional DNA testing at the discretion of the Illinois Hereford Association.
44. All animals exhibited are subject to DNA profile tests to verify breed purity and accuracy of the recorded parentage. Rules detailing DNA profiling of Hereford animals can be found in the AHA Rules and Regulations Handbook at www.hereford.org.

Shorthorn and Shorthorn Plus

45. Eligibility requirement to show Shorthorn is 15/16 and higher and Shorthorn Plus 50% to 7/8, as verified by an American Shorthorn Association (ASA) registration certificate. An ASA registration certificate will indicate effective date of ownership.
46. Multiple owned animals must be exhibited in the name of all owners.
47. Shorthorns and Polled Shorthorns are subject to tattoo inspection by representatives of the ASA. All Shorthorns and Polled Shorthorns are also subject to an age inspection if deemed necessary by the ASA and the decision of the examining veterinarian is final.
48. Individual classes of both sexes will be divided by an appointed committee as nearly equal as possible with no more than thirty (30) classes. Variation of division of numbers per class will be dependent upon age differential. The appointed committee will make official division of classes no later than twenty-four (24) hours after the official stalling deadline and not before twelve (12) hours after stalling deadline.

Charolais

49. Eligibility requirement to show is purebred as verified by an American-International Charolais Association (AICA) registration certificate. An AICA registration certificate will indicate effective date of ownership. An animal is eligible to enter or compete in an open Charolais breeding class if registered in country of origin outside the United States and is eligible for purebred registry in the AICA Herd Book.
50. Animals registered in the AICA Colored Division Registry (QF and QM initialed registration numbers) must meet the parameters of the AICA Color Card.
51. All animals to be eligible may be approved by a sifting committee designated by the AICA.
52. Any animal not having a legible tattoo or firebrand number is ineligible and will be barred from showing.
53. Junior and Senior Bulls must have a valid, satisfactory semen test certificate in possession. This certificate is valid for the entire show season.
54. All animals are subject to a medical examination in order to determine age, and each animal will be present in the show ring in its natural conformation without alteration or modification.
55. AICA requires that all animals be shown with a halter and suggests that all bulls be shown with a nose lead.
56. All exhibitors of Charolais Breeding Cattle shall be governed by the AICA Rules and Regulations, Article XV, Exhibitions of Animals. The inspections of exhibit cattle are specified in Article XV, Paragraph C, and consequence of non-compliance of exhibit inspection is specified in Paragraph D of the same article.
57. Individual classes of both sexes will be divided by an appointed committee as nearly equal as possible with no more than twenty (20) classes. Variation of division of numbers per class will be dependent upon age differential. The appointed committee will make official division of classes no later than twenty-four (24) hours after the official stalling deadline and not before twelve (12) hours after stalling deadline.

Simmental

58. Eligibility requirement to show for females and bulls is purebred as verified by an official American Simmental Association (ASA) registration certificate. Eligibility requirements for steers to show is 1/2 or higher as verified by an ASA registration certificate. Commercial percentage shall not be included as part of Simmental classification percentage. Simmental registration certificate will indicate effective date of ownership.
59. Calves born in 2023 must have a registration paper to verify them.
60. Any animal not having a legible tattoo is ineligible to compete and will be barred from showing.
61. Individual classes of both sexes will be divided by an appointed committee as nearly equal as possible with no more than thirty (30) classes.

Low Percent Simmental

62. Eligibility requirements for females and bulls to show is 1/2 SM to 3/4 SM and a recorded registration certificate with the American Simmental Association (ASA).
63. Calves born in 2023 must have a registration paper to verify them.
64. Any animal not having a legible tattoo is ineligible to compete and will be barred from showing.
65. Individual classes of both sexes will be divided by an appointed committee as nearly equal as possible with no more than thirty (30) classes.

Limousin and Limousin Flex

66. All animals must be registered with the North American Limousin Foundation (NALF). Any animal over thirty (30) days of age, including calves to be shown at side of dam, must have proof of a registration certificate and be recorded with the NALF. For ET calves, parentage verification paperwork must be in NALF system. All animals must be 75% (NALF Percentage, not actual), or greater, as indicated on orange NALF registration certificate or purple-papered Lim-Flex Cattle as indicated by NALF registration certificate. Percentage, full blood, Purebred and Lim-Flex shall compete in the same classes and championships.
67. Any animal not having a legible tattoo is ineligible to compete and will be barred from showing.

68. Individual classes of both sexes will be divided by an appointed committee as nearly equal as possible with no more than twenty (20) classes. No class shall contain more than twenty (20) head or have an age spread of more than sixty (60) days unless the animals are over two (2) years old.
69. All bulls over one (1) year of age must show with a nose lead.
70. Calves exhibited alongside dams in the cow-calf division are eligible to show as individuals as long as the calf is registered and qualifies as determined by purple registration papers from NALF. All animals shown must be solid red or black above the flanks, excluding birth marks.

Maine Anjou and Maintainer

71. All animals must be registered in the American Maine Anjou Association (AMAA) as verified by an official AMAA registration certificate. All Maine Anjou females and bulls must be 75% or greater. Maintainer females and bulls must be one quarter or greater.
72. Any animal not having a legible tattoo is ineligible to compete and will be barred from showing.
73. Animals over seven (7) months of age must be dehorned.
74. Heifers exhibited at twenty (20) months of age or older must be accompanied by a certificate of pregnancy. For heifers used in embryo transfer, a certificate of positive fertility issued by a licensed veterinarian must be available for inspection.
75. Bulls exhibited at fourteen (14) months of age or older must have had a positive semen test and a certificate to that effect must be available for inspection.
76. Individual classes of both sexes will be divided by an appointed committee as nearly equal as possible with no more than twenty (20) classes. Variation of division of numbers per class will be dependent upon age differential. The appointed committee will make official division of classes no later than twenty-four (24) hours after the official stalling deadline and not before twelve (12) hours after stalling deadline.
77. All bulls twenty (20) months of age or older must show with a nose-lead.
78. Any and all cattle shall be available to have hair pulled or parentage verification, detection of foreign substances, or the presence of alterations. If recorded parent is excluded as a result of blood typing the owner may, at his expense, request the AMAA determine actual parentage. Failure to determine parentage will result in disqualification of that animal from the AMAA herd book.

Special Definitions and Recognitions

Exhibitor definition in certain classes: In individual classes, the exhibitor is defined as the person whose name appears on the registration paper as the owner. In group classes where the herd is one (1) unit with animals registered in the names of different members of a family residing on one (1) farm, entries may be made under the name of a single exhibitor.

Cow/Calf: Cow with most recent natural calf no more than 250 days of age at her side. Cows cannot turn more than five (5) years of age in the current calendar year. The cow/calf entry is eligible for inclusion in group classes but will be considered one (1) animal in those classes, except for groups of six (6) animals in which both cow and calf may be counted as individual animals.

Produce of Dam: Group to consist of two (2) animals, any age, either sex, the produce of one (1) dam. Animals may be owned by more than one (1) exhibitor and must be shown in individual classes.

Two Females or Pair of Females: Group consists of two (2) female animals of any age, bred and owned or co-owned by breeder/exhibitor. Animals must be shown in individual classes.

Two Bulls: Group consists of two (2) bulls of any age, bred and owned or co-owned by breeder/exhibitor. Animals must be shown in individual classes.

Super Cow Class: Cow with two (2) offspring of either sex or any age. Offspring do not need to be owned by the same exhibitor. Animals must be shown in individual classes.

Junior Get of Sire: Group to consist of three (3) animals by one (1) sire with both sexes represented. Animals must be shown in individual classes.

Breeders Herd of Four or Best Four Head: Group to consist of four (4) animals, with both sexes represented, owned or co-owned by breeder/exhibitor. Animals must be shown in individual classes.

Breeders Herd of Five, Group of Five, or Breeders Best of Five Head: Group to consist of five (5) animals, with both sexes represented, owned or co-owned by breeder/exhibitor. Animals must be shown in individual classes.

Breeders Six Head or Best Six Head: Group to consist of six (6) animals, with both sexes represented, of which the exhibitor is the breeder and first owner of the animals. Animals may be currently owned by different individuals, as long as the exhibitor was the breeder and first owner as identified on registration certificates. Animals must be shown in individual classes. For purposes of this class only, a cow-calf entry may be considered two (2) animals.

Special Awards

Grand Champion Females and Bulls of the Open and Land of Lincoln Shows: Banners will be given by the Illinois State Fair to the exhibitor of the Open and Land of Lincoln Show Grand Champion Females and Bulls of each breed division at the 2024 Illinois State Fair.

Grand Champion Steer: The Champion Steer of each breed will compete for Grand Champion Steer of the Open and Land of Lincoln Shows on Sunday, August 11. A plaque will be given by the Illinois State Fair to the exhibitor of each of the Open and Land of Lincoln Show Grand Champion Steers for the 2024 Illinois State Fair.

Grand Champion Cow/Calf: A Grand and Reserve Champion Cow/Calf will be named for each breed.

Premiere Herdsman Award: Upon decision of the Beef Cattle Superintendent, a banner will be given by the Illinois State Fair to the Premiere Herdsman in each breed.
