ay 1 ove FOR THE FAIR'S LAST NIGHT, PLEASE REMEMBER:

- **INSIDE VENDORS:** Must be open until the start of the last scheduled Grandstand event at 8:00pm. You may stay open until the building closes at 9:00pm if you choose.
- **OUTSIDE VENDORS:** Must remain open until after the start of the last scheduled Grandstand event at 8:00PM but may remain open until 12:00AM.

It is a violation of your contract to close early. Violators of contract rules will not be invited back. You also <u>must report</u> and <u>pay</u> IL Sales Tax on the form provided to you by IL Dept of Revenue. This form must be postmarked by September 9, 2023.
